## 56th Annual Courthouse Purchase Award Contest

The purpose of this show is to showcase Waukesha County artists. It is co-sponsored by Waukesha County and the Waukesha Creative Arts League. Dates may change subject to COVID 19 situation.

The artwork submitted must be an original creation of yours or from a photograph of yours. If taken from any "online" material, printed material of any sort or photo not yours, written permission must be obtained from the photographer or original artist and must be included with your entry form. Reproductions of any type, i.e., giclée etc., of the artwork are not acceptable. The hanging method must be secure. Hanging must be with wire. No saw-tooth hangers will be accepted. Artwork may be two or three-dimensional.

### **The contest is open to any Waukesha County amateur artist, 18 years and older as of the entry date.**

All artworks will be displayed in the Waukesha County Courthouse Gallery end-September through October. The winner of the Purchase Award agrees to accept \$350 regardless of the value stated on the entry form. In addition, the winning work will become part of the permanent collection at the Courthouse. A brass plate noting the title, artist's name, and city, medium and year of the award will be affixed to the work. Second and Third places as well as Honorable Mention will receive cash awards.

## Entry Instructions

The Purchase Award may be won once every three years by any artist, up to a maximum of three wins. Second, Third, and Honorable Mentions may be won annually.
